### MEMORANDUM

As notified vide No.F. No.F. 4(82)/ADC/PO/I &C/E-Auto/2025-26/ 1064. Dated, 28/11/2025, it is decided that 1600 Nos. Bajaj Passenger & Goods Carrier Auto will be distributed to different interested unemployed Tiprasa youths on subsidy basis under TIPRA HAM Scheme during the year 2025-26.

In this regard, a subsidy of Rs. 80,000/- (Rupees Eighty thousand) only will be provided by TTAADC against the actual cost of each Bajaj Passenger & Goods Carrier Auto to be owned by each selected beneficiary upon payment of required margin money by the beneficiaries as mentioned below:


The Application Fee for the purpose is fixed for Rs. 300/- .

A subsidy of ₹80,000 will be provided by TTAADC to each selected beneficiary upon payment of the required margin money as mentioned below:


Rate of Required Margin Money as follows:

1. Passenger E-Auto (9 KW): @ Rs.25,000
2. Goods Carrier E-Auto (9 KW): @ Rs.30,000
3. Goods Carrier E-Auto (12 KW): @ Rs.35,000

Application Fee:

- ₹300 (Non-refundable), per applicant.

Eligible applicants may submit their applications through their respective Zonal/Sub-Zonal Offices from 28th November 2025 to 16th December 2025, subject to the terms and conditions prescribed under the Scheme. ## TIPRA HAM AUTO LOAN

The TIPRA HAM Loan Scheme is a suite of financial initiatives by the Tripura Tribal Areas Autonomous District Council (TTAACD) designed to empower the indigenous Tiprasa community by providing accessible and affordable loans across various sectors. This scheme aims to promote socio-economic development, financial inclusion and overall well-being of the Tiprasa people. Tipra-Ham Auto loan is one of such scheme.

### **1. Objective of the scheme:-**


- To enhance mobility and support entrepreneurial ventures through the provision of auto loan for commercial purpose.
- To provide a sustainable income to unemployed Indigenous youths within TTAADC areas.
- To increase the wage earning capacity of the unemployed Indigenous youths.
- To contribute to the growth of employment economy in TTAADC areas.

### **2. Eligibility Criteria:-**

- The applicant should be permanent resident of TTAADC area.
- The applicant must be the ages of 21 to 45 yrs.
- Educational qualification minimum class- VIII(Eight) pass.
- The applicant's house should have electrical connection.
- Only one person in a family is eligible for loan. Family includes 'self and spouse'.
- Govt. Servant is not eligible for this loan.
- Copy of ROR/ Family Ration Card.
- Earlier E-Auto loan under Tipra-Ham scheme those are got not entitled.

### **3. Nature of Financial Assistance and Repayment of the Loan:-**

- Beneficiary will be paid Margin Money and Subsidy is Rs. 80,000/- of the total cost of the Auto to be paid by TTAADC to the Tripura Automobiles.

- Beneficiary contribution is Rs. 25,000/- of the total cost of the Passenger career E-Auto(9 KW), Rs. 30,000/- (E-Auto - 9KW) and Rs. 35,000/- (E-Auto -12 KW) of the total cost of the goods career and the rest amount will have to be paid monthly on a fixed due date by the beneficiary at his own.
- The beneficiary is not to be borne the cost of installation of electric charging point of the auto for passenger and Goods Career.
- The tenure of the loan will be maximum 48 months.

#### **4. Security and Collateral:-**

- Collateral: The vehicle itself serves as collateral for the loan.
- Hypothecation: The process of hypothecating the vehicle to the lender until the loan is fully repaid.

#### **5. Application procedures:-**

- Applicant can apply as per prescribed application form through offline.
- No application will be received directly on offline mode/Hard Copy.
- Processing/application fee @Rs. 300/- be deposited by the applicant to the account of TTAADC through offline mode ZDOs & Sub-ZDOs.
- Application fee is non refundable.

#### **6. Selection of Beneficiaries:-**

- Application received will be scrutinized by a scrutiny committee.
- After scrutiny of the applications, the final approval will be obtained from the authority, TTAADC and it will be forwarded to the NBFC, Bajaj Auto credit LTD.(BACL) for sanctioning loan.
- The Authority of TTAADC have the Right to reject and cancel the application without assigning any reason.
